

## Strathcona BIA Board of Directors Election 2022

Members in good standing of the Society of the Strathcona Business Improvement Association (SBIA) are invited to review the four incumbent candidates and two new candidates up for election for the Board of Directors at the 2022 Annual General Meeting (AGM).

Every year, the board reviews the existing collective skills, attributes and experience of its directors to identify gaps or priorities, as informed by the SBIA's strategic vision and goals. This is to ensure an optional board governance structure is in place to effectively guide the organization. A list of desired attributes, experience, and interests for directors is communicated to members as part of the [Call for Nominations](#).

As part of the 2022 Call for Nominations process the SBIA received six completed nomination packages. At the 2022 AGM members will vote on how many seats will be assigned to the board for the ensuing year. Your Board of Directors is proposing that the board size be set at 11 seats for the ensuing year. If passed the six candidates up for election would all join the board via acclimation. As per the SBIA bylaws, the Board of Directors can have as few as 8 seats and as many as 12 seats.
