Strathcona BIA Membership Application Form 2023

Before you start your application

Please review the following information to understand why and how to submit a membership application form. You must submit a membership application to vote and to become a member of good standing in the society.

Who is eligible to vote

In order to cast a vote, you must be a property owner of a class "5" or class "6" property, and/or must be tenants of a property owner of a class "5" or class "6" property within the Strathcona Business Improvement Association's boundaries for six months prior to the date of registration as shown on the current City of Vancouver Tax Assessment Roll or have signed a lease for an unexpired term of no less than six months from the date of the application. Tenants must hold a valid City of Vancouver business license.

If you own/represent multiple businesses/properties

If you own multiple businesses or properties under separate legal entities, please provide the business/property holding name and address of each business/property. You can do this by submitting multiple membership applications or emailing info@strathconabia.com with a list of each business/property you wish to apply for. After you have submitted your form, Strathcona BIA staff will contact you to confirm your membership status.

If you cannot attend the AGM

Members who cannot attend the AGM are encouraged to submit a membership application to ensure they register as members in good standing of the society and to designate another member in good standing of the society as their proxy to vote on their behalf.

Deadline to submit

Per our bylaws, you must **COMPLETE** and **RETURN** the membership application on the backside of this page at least 5 business days before the AGM. The deadline to submit your membership application is **Thursday, September 14 at 11:30am**. Members who submit forms after the deadline may not be eligible to vote and formally participate in the AGM.
